Service Work or repairs done at a customer's request or to repair damage will be charged the cost of labor and materials required. Charges are assessed to the person requesting service or to the party responsible for damages.

1. Any additional trips to restore service where the water is turned off for nonpayment will result in a service call charge being added to the customer's account.
2. A tampering charge will be assigned to the account holder for the service where there is evidence of tampering.
